period of 2 months. Stackability depends on many factors and the above data is meant as an indication only. Consequently, customers should make internal trials to dertermine the viability of stacking and transportation.

Hot temperatures: The material chosen has a very good heat resistance and the packaging is suitable for hot filling. Notably,

plastic packaging become flexible when subjected to hot filling temperatures and care must be taken in relation to stacking immediately after hot filling. The Superfos packaging must be tested by the customer with

the actual product before approval for use at hot temperatures.

Cold temperatures: Freezing conditions require special resins available on request. The Superfos packaging must be tested by

the customer with the actual product before approval for use at low temperatures.
