UN SuperSafe with two lid types

UN SuperSafe is available with two lid types which both fit the same packaging body. An integrated standard lid, which can be opened in the pouring spout only, provides for a perfectly tight and sealed packaging solution.

Another lid has a visually clear safety tear-of-band throughout the external diameter of the container. This is a convenient solution if you want to get the benefits of using the same container body for your other goods which do not need UN approved packaging. This lid type can be entirely removed thanks to the safety tear-of-band, making it easy to stack the empty containers and save storage space.

Child proof UN approved lid for UN SuperFlex

Berry Superfos also offers a unique solution in the form of a child proof lid in the UN SuperFlex Series. The child proof lid is available for UN approved containers with a diameter of 222 mm and is suitable for products for the swimming pool. The lid is approved in Europe according to the NF EN ISO 8317 standard. It is impossible to open for children under 51 months (just above 4 years old) while it is easy to open for adults including seniors.

All the UN approved containers can be delivered in many different sizes from 3 litres to 32.2 litres. They have functional details and offer ample opportunities for great branding on the packaging, as it is the case for all other packaging solutions from our container range.
